1. I am the named Plaintiff in this above-captioned putative class action against NutriBullet LLC (“Defendant” or “NutriBullet”). If called as a witness, I would competently testify to the matters herein from personal knowledge.
2. I am filing this declaration in support of the Motion for Attorneys’ Fees, Costs and Service Award.
3. I have been appointed Class Representative for this product false advertising class action settlement.
4. I reviewed and signed the written Settlement Agreement and I have discussed it with my counsel, and I also later on reviewed and signed the Addendum to the Settlement Agreement.



- 1 5. I have participated throughout the litigation against Defendant in the belief I was helping all  
2 other persons similarly situated. After the initial consultation, I participated in calls and emails  
3 regarding fact-finding efforts with my attorneys. I have provided documentary evidence of  
4 my claims to my attorneys.
- 5 6. I responded promptly to any requests for information from my attorneys and made myself  
6 readily available in the event that I was needed during the mediation that took place in August  
7 of 2021.
- 8 7. I previously signed a declaration in support of a motion for preliminary approval of the class  
9 action settlement.
- 10 8. I understand that my attorneys are requesting that, as Class Representative, I be awarded a  
11 service award of \$3,000 for my efforts in this lawsuit to represent the putative class members.  
12 I understand that any such award has to be approved by the Court. I am not receiving any  
13 monetary compensation from my attorneys (aside from this application for a service award  
14 subject to court approval) for bringing this lawsuit.
- 15 9. I support the motion for attorneys' fees, costs and service award.
